The Estonian text of the Constitution of the Republic of Estonia and the Citizenship Act, as well as the dictionary may be referred to at the examination. All the materials are available in the examination room.

The result of the examination will be communicated within 14 days as of the date of the examination by post or e-mail. The pass mark of the examination is at least 18 correct answers out of 24. The examination certificate will be issued in electronic form, which can be viewed on and downloaded from the official government portal www.eesti.ee

Those who are unable to take the examination according to the standard procedure owing to their medical status can apply for a modification of the scope or manner of taking the examination. For this they must submit to the Foundation Innove a corresponding application accompanied by a medical specialist's certificate on their medical status, which will be reviewed by an expert committee.



The examination on the knowledge of the Constitution of the Republic of Estonia and the Citizenship Act



The examination on the knowledge of the Constitution of the Republic of Estonia and the Citizenship Act (Examination) is designed for those who wish to apply for Estonian citizenship.

## The examination is held 12 times a year in Tallinn, Narva, Jõhvi and Tartu and twice a year in Pärnu, Rakvere and Valga.

The examination takes place on the same date and at the same time at all the examination centres.

Taking the examination is free of charge.

## You can register for the exam:

- on the official government portal www.eesti.ee;
- by sending or taking to the Foundation Innove a standard application accompanied by a copy of the ID card. The application form is available on the Foundation Innove webpage.

## You cannot register for the examination by phone.

**Free consultations** are available prior to the examination. The consultations are open to all who wish to learn about the content and format of the examination and check their preparation for the examination. A notice of the time and place of the consultations and the examination is sent to the registered participants 7 days before the examination at the latest.

It is a written examination with 24 multiple choice questions. For each question, the one correct answer must be marked. All the questions are in Estonian. You have 45 minutes to take the examination.

## The examination questions involve the following areas:

- The fundamental principles of the Estonian form of government, stipulated in Chapters I and III of the Constitution of the Republic of Estonia;
- The fundamental rights, freedoms and duties of each person, stipulated in Chapter II of the Constitution of the Republic of Estonia;
- The jurisdiction of the *Riigikogu*, the President of the Republic, the Government of the Republic and the courts according to the Constitution of the Republic of Estonia;
- The conditions and procedure for the acquisition, resumption and loss of Estonian citizenship according to the Citizenship Act.
